After reading each item below, please indicate that you have read and agreed to terms by initialling next to each section. All sections must be completed. We are unable to process incomplete applications.

Arts Clayton determines operation rules and procedures based on our permits and regulations set forth by city ordinance, to provide a cohesive well-managed event. This ensures the safety and protection of attendees/participants and to protect the public space from undo harm or damage. Arts Clayton expects all artists/vendors/sponsors to respect and observe operating rules and regulations.

If selected as an artist/vendor to participate in the "Market on Main" event, I understand and will adhere to all operating rules and procedures listed below. Agreements are subject to change and may be provided at a later date.

- ★ My booth will open for business during the full hours of the event as listed above. \_\_\_\_\_
- ★ This is an indoor/outdoor event. It is my responsibility to prepare for weather contingencies. Arts Clayton will determine when/if it is fit to close in the event of weather emergencies. \_\_\_\_\_
- ★ I will attach sufficient weight on all corners of the tent/booth to prevent injury to artists/guests. I want to protect my work and the work of the artists around me and protect the safety of the public, fellow exhibitors, staff, etc. ( All tents must be approved prior to setup by Arts Clayton) \_\_\_\_\_
- ★ I will not stake any items into the ground, nearby trees, shrubs or other objects in the area. \_\_\_\_\_
- ★ Set up will take place on the date of the event 8:00-9:00 am (unless otherwise notified) and I will adhere to times and instructions of an orderly set-up. \_\_\_\_\_
- ★ I will not drive my vehicle on grass or turf. All wheels of my vehicle will remain on asphalt or other hard surfaces at all times. \_\_\_\_\_
- ★ I will pick up/ clean up around my booth space before leaving the area on Saturday between 1:00 - 2:00 pm leaving the area "better than I found it". \_\_\_\_\_
- ★ I understand fees paid help Arts Clayton in the overall production of the event including but not limited to marketing/promotion, staging, signage, etc. If I need to withdraw from the event, I will do so in writing by May 18th. I understand that after May 18th, no refunds are available. \_\_\_\_\_
- ★ I understand that possession or sale of drugs/alcoholic beverages by any artist/vendor will result in immediate removal of the offending artist/vendor and could result in prosecution. In the event of alcohol or drug related infractions NO REFUNDS will be awarded. \_\_\_\_\_
- ★ I will display/sell my work as represented in the application submitted. Arts Clayton reserves the right to remove/reject any art that does not reflect the artist's personal work or similar to that of the original application. \_\_\_\_\_
- ★ Booth sharing is not permitted without prior written consent of Arts Clayton. \_\_\_\_\_
- ★ I understand that pets are not allowed during the event. \_\_\_\_\_
